

MCC iPad/Computer Code of Conduct

Student Procedures for iPads / MacBooks

Students and their Parent/Carer will be required to agree to this iPad/Computer code of conduct at the beginning of the school year.

General

- MacKillop uses Apple Classroom to monitor student use of iPads during lessons.
- At no time will permission be granted to individuals or groups of students to use their iPads/MacBooks before school, at Break 1, Break 2 or after school, unless in a College classroom or the library. Non-compliance with this request will be viewed as a breach of the school rules and will result in consequences.
- Students must remain connected to the school network during the school day. Use of VPN's (virtual private networks) are not permitted at school.

Student iPads left at home

- If a student leaves their iPad at home, they are responsible for getting the assigned work completed by other means in the least disruption to other students in the class.
- If students are unable to bring their iPad to school they should bring a note signed by a parent/carer.
- A limited number of loan iPads are available at the College for single day loans.

Charging of Student iPads

- iPads must be brought to school each day with the battery fully charged. It is the responsibility of the student to charge his/her iPad each evening. Please note that regular daily lessons will not exceed the capacity of an iPad's fully charged battery.
- iPad chargers are not available at school, and students will only be allowed to charge their iPads (with their own charger) during school time either in the Library or at the discretion of their teacher.

Student Wallpapers and Background Images on the iPad

• Inappropriate media may not be used as screensavers or wallpapers on the iPad - the presence of firearms, profanities, aggressive or violent behaviour, alcohol, prohibited substances or harassing/distasteful pictures are not permitted.

• Students are not permitted to take photos or videos of other students whilst at school, unless in class with the permission of their teacher. No images are to be stored on a student's iPad of other students.

Audio and Games on the iPad

- Students are to ensure that the iPad audio is muted at all times unless permission is obtained from the classroom teacher.
- Music is allowed on the iPad and can be used at the discretion of the teacher.
- Games are allowed to be on the iPads, but may not be played at school at any time.
- Students are required to carry earphones with them in the event of audio required in class. These are to be used at the discretion of the classroom teacher.

Print Services on the iPad

At this stage, print services are not available from the iPads or MacBooks.

Inspection of student iPads

Students may be asked to provide their iPad for inspection to determine the
appropriateness of apps installed on their device. This may be done by any teaching
staff member if there is a reasonable concern that the device holds something
inappropriate.

iPad Infringement Procedure

- Students will receive an iPad infringement in Compass if they:
 - use their ipad inappropriately during class time (eg for non class based work, playing games, using a VPN etc)
 - do not bring their ipad to school and do not have a parent/carer note of explanation
 - bring an uncharged ipad to school
- Students who receive three ipad infringements within a term will receive a short afternoon detention.
